Conditions of Entries

1. Entry Fees - \$10 per individual entry/competitor, \$40 per team entry.
2. The number of entries will determine how the event is structured (heats with progression to final).
3. Advancement to the final is based on the fastest times, not necessarily on the heat winners. This means competitors in different heats can still have a chance to move forward based on their time performance.
4. Competitors must complete the rally course and its tasks correctly to achieve a successful time. If tasks are not completed correctly, the time may not count as valid.
5. Time penalties may be imposed at the discretion of the judges for mistakes or rule violations during the event.
6. The judges have the final say in any decisions, and their rulings are final.
